The Board of Trustees met in Regular Session Monday, May 6, 2019, at 7:04 p.m. in the Village Hall.

The Meeting was called to order by President Ryan Marucco with the following Members present:

After the Adjourned Meeting was called to order, newly-elected Village Trustees David Blakeman, Tara Ramsey, and Nathan Rybolt were sworn in by President Ryan Marucco.

Motion by Callan, seconded by Thomason, to approve the committee appointments. Motion passed with a 6/0 vote.

RESOLUTION NUMBER 19-451 – A RESOLUTION Of Support Of The Village Of Stonington, Christian County, Illinois

Motion made by Blakeman, seconded by Dowdy, to pass **RESOLUTION 19-451** Of Support Of The Village Of Stonington, Christian County, Illinois. **Motion** passed with a roll call that went as follows: Dowdy "Yea"; Rybolt "Yea"; Ramsey "Yea"; Blakeman "Yea", Thomason "Yea", and Callan "Yea". **Motion** passed with a 6/0 vote.

President Marucco opened the following sealed bids for the demolition of Village owned buildings. Bids went as follows:

- 1. Bid from TRB Inc. in the amount of \$82,500
- 2. Hutchens Bulldozing Inc. in the amount of \$92,500
- 3. Joe Coleman Salvage Inc. in the amount of \$82,725
- 4. Building Systems of Illinois in the amount of \$164.174
- 5. M & H Excavating in the amount of \$64,000

President Marucco asked for a motion to award the demolition bid. **Motion** by Dowdy, seconded by Thomason, to award the lowest bid to M & H Excavating in the amount of \$64,000. This is pending the utilities getting shut off and items removed from the building. **Motion** passed with a 6/0 vote.

President Marucco welcomed Stacey Etheridge on behalf of the American Legion to the table. The American Legion is starting the Queen of Hearts. Their first drawing will be held on Thursday, May 23, 2019 at 8:00 p.m. They will cap out their raffle at \$500,000.00.

A **motion** was made by Blakeman, seconded by Dowdy to authorize a Liquor License to the Summerfest Committee for use June 21-23, 2019. **Motion** passed with a roll call vote that went as follows: Dowdy "Yea"; Rybolt "Yea"; Ramsey "Yea"; Blakeman, "Yea", Thomason "Yea", and Callan "Yea". **Motion** passed with a 6/0 vote.

President Marucco welcomed Jenny Prasun and Jodi Rusher to the table as co-chairs of the Stonington Summerfest. They presented the Board with the profit/loss statement for the 2018 Summerfest. They announced that this year's event will be held June 21, 22, and 23, 2019. The theme for this year's Summerfest is "Out of this World".

They requested to close Lake Street from Wabash to North Street and North Street from Railroad Tracks to Church Street and Walnut Street from 3rd Street to North Street during the weekend events. On behalf of the committee they asked for a donation from the Village towards firework expenses.

A **motion** was made by Dowdy, seconded by Thomason, to donate \$2,000.00 towards the Summerfest fireworks. **Motion** passed with a 6/0 vote.

President Marucco welcomed Kevin Walker from Legacy Grain to the table. Kevin presented to the Board a project overview of building a new tank. Would like to start the project early June and be completed by October, 2019. He asked to obtain a permit for the project.

Kyle Parks thanked the Village for helping clean up the property next to his property. There is still work to be done. He mentioned that he is still mowing the ditch at the street which the Village abandoned. He also had a question about the concrete parking lot between north street and the drive in front of the Firehouse.

The Streets Committee scheduled a meeting for Wednesday, May 15, 2019 at 6:30 p.m. to discuss the abandoned street.
